8. Consider and accept non-solicited donations from Texas Association of Counties.

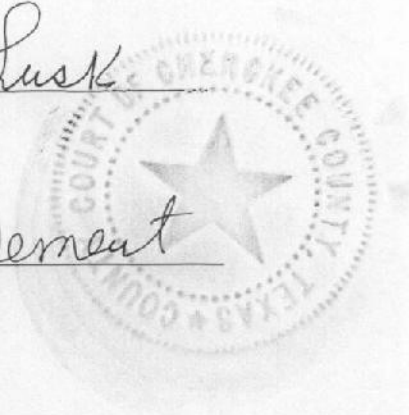
