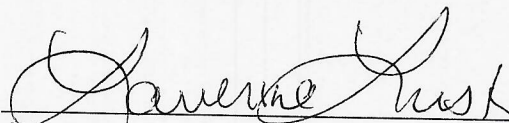

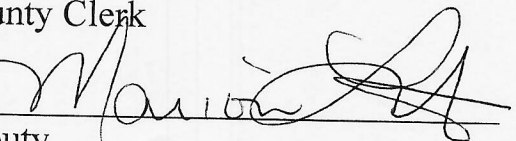
8. Consider appointment of person to the Board of the Neches Trinity Valleys Groundwater Conservation District.

11. Return from Executive Session and take action if needed.



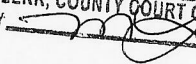

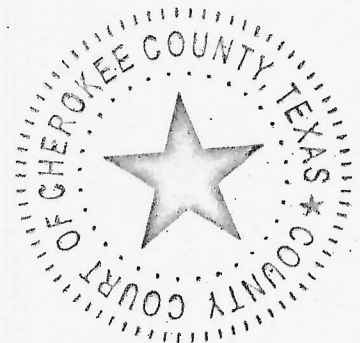


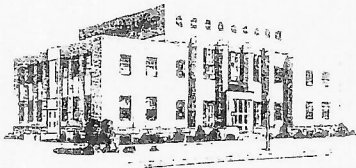
