7. Request authorization to enter into an agreement with Government Leasing Company for a lease to purchase of Volvo Truck by Precinct #3.

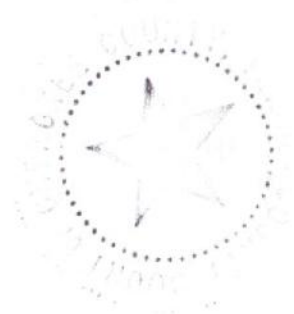
8. Consider and Accept the Vegetation Bids.
