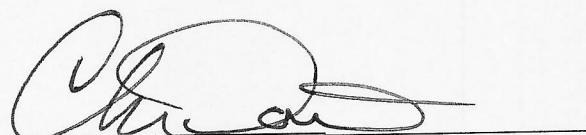
1. Call to Order.

 - 15.3 Consider and accept Auditors Monthly Report for June 2026.

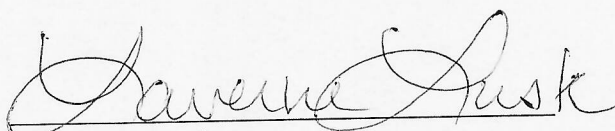

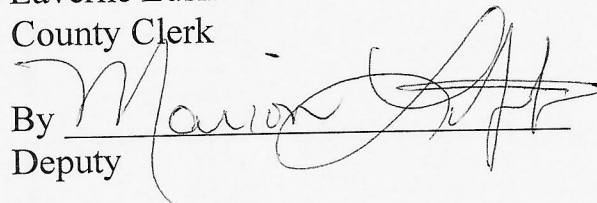

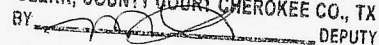
