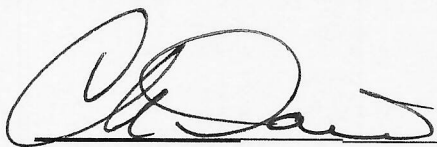

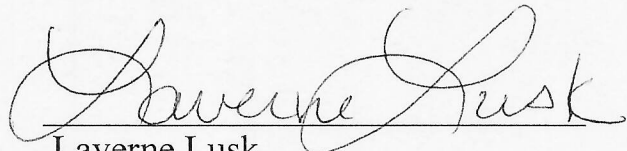

8. PUBLIC HEARING: On newly proposed Cherokee County Sub-division Regulations in unincorporated areas of Cherokee County, Texas.

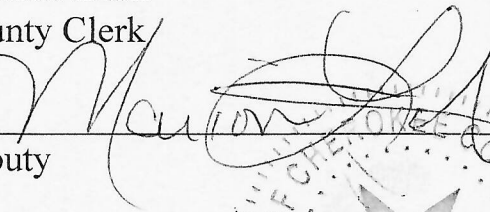
9. Discussion and take action concerning the adoption of newly proposed Cherokee County Subdivision Regulations in unincorporated areas of Cherokee County, Texas.

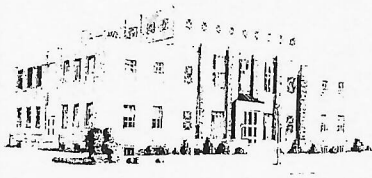
