
NOTICE OF MEETING

NOTICE is hereby given that the Cherokee County Commissioners' Court will meet in Regular Session at 9:00 a.m. on Tuesday, September 24, 2024 at its regular meeting place in the County Courtroom in the County Courthouse in the City of Rusk, Texas, for the purpose of:

1. Call to Order.
2. Invocation.
3. Presentation of the Distinguished Service Award to the Cherokee County Historical Commission.
4. Consider and approve the Sheriff's Office to purchase employee uniforms in lieu of a monthly payment.
5. Consider and approve the Sheriff's Office to purchase 2 patrol vehicles through Cameron County Dodge before October 1, 2024 using SB 22 funding.
6. Consider and approve the Sheriff's Office to purchase 3 patrol vehicles through Cameron County Dodge before October 1, 2024 using the 2024-2025 budget.
7. Consider and accept 2025 County Choice Silver Insurance plan for retirees over 65.


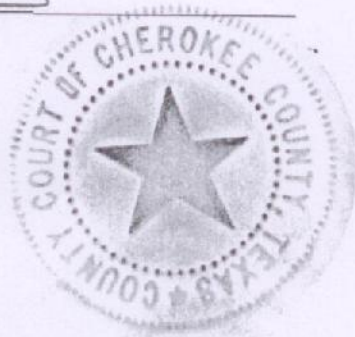
